About POSH Act:

- Enforced on 9th December 2013, the POSH Act mandates that all organizations with 10 or more employees establish an ICC.
- The Act provides guidelines for preventing, prohibiting, and redressing sexual harassment.
- Recognized and reinforced by the UGC Regulations, 2015 for higher educational institutions.

Definition of Sexual Harassment:

Includes physical contact, demands for sexual favors, sexually colored remarks, unwelcome physical, verbal, or non-verbal conduct of a sexual nature.

Why ICC Is Essential:

- To implement the POSH Act provisions.
- To safeguard the rights and dignity of women at the workplace.
- To foster a gender-sensitive environment in academic and administrative spaces.

Who Can Approach the ICC:

Any aggrieved woman who is:

- An employee (teaching or non-teaching)
- A student
- A visitor to the workplace

If the woman cannot file a complaint, her legal heir or representative may file on her behalf.

Functions and Responsibilities of ICC:

- Prevent sexual harassment in the workplace.
- Promote gender amity among students and staff.
- Conduct awareness and sensitization programmes regularly.
- Receive complaints of harassment and conduct unbiased inquiries.
- Maintain confidentiality and ensure redressal in a timely and just manner.
- Submit annual reports to the District Officer and the Employer.
