- To ensure prevention of academic misconduct including Plagiarism in academic/research writing.
- Sensitization of Students, Teachers and Research Scholars to the social, ethical, and legal aspects of their research
- Governance of Research Promotion in the College through Research Advisory Committee directing the conduct of research and safeguarding ethics and academic integrity in scientific research
- Effective channeling of Research Activities of the College into the Entrepreneurship Development Cell and Institution Innovation Council and furthering the nexus to PSG-STEP

- Periodical review of Research Record Book of Ph.D. Scholars by the Research Supervisors and Research Coordinator.
- Strengthening Inter-institutional linkages/collaborations for collaborative research/performing experiments/Doctoral Committee
- Monthly meeting of the Research Scholars and Faculty Members with the R&D Adviser appointed by PSG Institutions
- Conducting Research-themed Guest Lectures, Seminars, Conferences, Workshops and FDP for faculty members, Research Scholars and Students
- Faculty members to participate in the Workshops and FDPs related to Research organised by PSG Center for Academic Research and Excellence (PSGCARE)
- Maximal utilisation of Central Research Laboratory
- Regular meetings of the Research Forum, Science Forum and Journal Club
- Encouraging the faculty members, Research Scholars and students to visit Foreign Universities/Research Institutions for short-term research, conferences and other collaborative activities.
- Management provides financial support for the Faculty members to attend Conference/Seminar/Workshop.
- Channeling the research activities towards the identified Thrust Areas of Research
- Encouraging the Faculty members and Scholars to formulate research proposal, supporting them to approach funding agencies for presentation/Task force meetings/Midterm Review, and ensuring hassle free implementation of the research project and timely submission of Utilization Certificates.
- Honororium of faculty members for publishing in Scopus/SCI/SCIE indexed journals
- Provision of internet facilities to access E Resources for Research
- Institution of Seed Money for research on a competitive basis for early career teachers from 2020 onwards.
