Observations and Suggestions of the Committee

The College has shown significant growth in all the quality parameters with regard to accreditations and rankings. The College is adhering to the guidelines prescribed by the UGC. The Academic Attainment during 2018-19 presented by the Principal was excellent. The grant of autonomy to this Institution has been properly utilized. The Internet connectivity to a band width of 400 Mbps is laudable. Most of the recommendations made by the External Peer Team (2017-18) have been fulfilled, for example four patents have been filed out of which two have already been published. The College has implemented comprehensive MIS – LAUDEA with several operational modules. The College has adopted five villages and the students are socially immersed effectively. The following are the recommendations of the Peer Team:

- 1. The seed money for projects has already been initiated which could be extended to the research scholars and PG students.
- 2. Additional training may be imparted to the faculty members given for utilizing the ICT facility.
- 3. E-content lectures are to be developed for a time duration 30 minutes by faculty members.
- 4. Electronics laboratory to be augmented with IOT and Robotics technology with the help of Computer Science Department.
- 5. The research potential of the College is commendable and hence Policy Intervention Researches could be initiated.
- 6. The commendable initiatives of the College in introducing MOOC, NPTEL, SWAYAM etc courses. The College can contemplate on developing its own Online courses for the benefit of the students as well as other College students
- 7. The College can initiate a mechanism to monitor the Term-wise plan.
- 8. Innovation, Incubation and Entrepreneurship cell could be further strengthened in order to encourage the students more Start-ups.
- 9. Value-added courses could be extended for outsiders and this can be treated as Consultancy for the College.
- 10. Faculty may be motivated to do collaborative research publications.
- 11. Targets and Roadmaps for the development to be given by IQAC for all the departments

- 12. Video capturing facility can be extended to at least one class room in each department
- 13. Rare books available in the library could be digitalized at the earliest
- 14. The College can explore more student exchange programs with Foreign Universities
